The first Reimagining Conservation Forum – Working Together for Healthy Country was held in Meanjin / Brisbane on Yuggerah and Turrbal Country in 2022, and brought together Indigenous and non-Indigenous peoples to talk about how we can reimagine managing land and sea Country together.

In 2022, over 100 people who work on Country for culture and conservation came together from across Australia, centering Indigenous voices in a conversation about what is working, what is not working, and where change is needed.

Six key themes emerged from the 2022 forum:

- 1. A rights-based approach to conservation
- 2. Valuing culture and recognising Indigenous cultural authority
- 3. Weaving knowledge systems
- 4. Equity in managing Country
- 5. Managing Country together
- 6. Economic opportunities

These six key themes helped to inform clear priorities, actions and next steps for reimagining of conservation in Australia. This framework for continuous cross-cultural discourse within the conservation sector aims to empower Indigenous peoples to look after Country, their way.

This year, *Reimagining Conservation 2024* brings people together again to continue to share, discuss, build and strengthen Indigenous cultural authority and Indigenous leadership on Country.

Indigenous communities continue to face significant challenges including maintaining knowledge systems before they are lost, economic and structural disadvantage, poor funding and resources in very remote areas, pressures from development and threats such as wildfire, climate change and introduced pests and diseases.

We know that by amplifying the voices of First Nations communities, many of whom have historically been excluded from making decisions about the management of their lands and water, large-scale conservation success can be achieved.

We are dedicated to supporting community-based conservation on Country, with a sharp focus on biodiversity conservation. We approach challenges holistically and work under the two-way knowledge transfer framework of Voice, Choice, and Action (VCA), a TNC driven charter that recognises the rights, aspirations, challenges, knowledge and capacity of First Nations communities.

This framework works to support self-determination, community-led conservation and development initiatives based on each communities aspirations for the health of people and Country. Broadly speaking, TNC helps to facilitate the resources and relationships to enable the best model of care at scale with longevity. We develop and hone a range of tools that we share on invitation with First Nations groups, tools such as the Healthy Country Planning (HCP) and Development by Design (DbD) approaches that work to amplify First Nations voices and recognise aspirations.



Parks Australia Platinum Sponsor

Parks Australia, under the direction of the Director of National Parks, looks after Australia's natural and cultural treasures.

We are responsible for the conservation and management of six Commonwealth national parks, 60 Australian Marine Parks and the Australian National Botanic Gardens.

Our marine parks are part of a national system which covers 48% of Australian waters, one of the largest areas of marine parks in the world. The Australian Marine Parks we manage comprise the vast majority of this network.

Working in partnership with Traditional Owners and First Nations' communities to manage land and sea Country is at the heart of our work. Traditional Owners and First Nations communities have a unique connection to Country. Their knowledge and perspectives, formed over many thousands of years, are critical to the way that protected areas are managed.

Combining Traditional knowledge, with Western science and technology, such as drone monitoring and AI, provides opportunities to reimagine our approach to conservation. It is transforming the way we work with governments, local communities, ranger groups and Traditional Owners to support the management of land and sea Country.
